



THE BRODHEAD WATER AND LIGHT COMMISSION HELD ITS REGULAR MEETING ON WEDNESDAY, AUGUST 13, 2025. PRESIDENT MIKE OLSON CALLED THE MEETING TO ORDER AT 1:00 P.M.

PRESENT: MIKE OLSON, MIKE KING, CARROLL SHEAFOR, ED HOFF AND TERRI CHAPMAN. ABSENT: COUNCIL REP. PAUL NARAMORE.

LAURI MOREHART OF WPPI GAVE A PRESENTATION TO UPDATE THE WATER AND LIGHT ON CURRENT AND FUTURE GROWTH THAT WPPI IS WORKING ON. SHE EXCUSED HERSELF AT 1:36 P.M.

KING MADE A MOTION TO ACCEPT THE MINUTES OF THE JULY 15, 2025 MEETING AS PRESENTED, SHEAFOR SECONDED. MOTION CARRIED.

THE PROFIT-LOSS REPORT FOR JULY 2025 WAS REVIEWED WITH SHEAFOR MOVING TO ACCEPT THE REPORT, AS PRESENTED, INCLUDING CHECKS #3553 TO 3560, 21209 TO 21255 AND 8533 THROUGH 8546 ALONG WITH THE DELINQUENT LIST. KING SECONDED. MOTION CARRIED.

OLD BUSINESS: CHAPMAN PRESENTED TWO PAGES SHOWING THE NEW WATER RATES ALONG WITH THE PUBLIC FIRE CHARGES THAT THE PUBLIC SERVICE COMMISSION HAS APPROVED. THE DATE THE NEW RATES WILL GO INTO EFFECT IS SEPTEMBER 1, 2025. CUSTOMERS WILL NOT SEE THE INCREASED COSTS UNTIL THEIR OCTOBER 7, 2025 BILLS ARE SENT OUT.

NEW BUSINESS: LEAD AND GALVANIZED WATER REPLACEMENTS WERE DISCUSSED. HOFF TOLD THE COMMISSION WE WOULD NEED WATER TOOLS TO REPAIR WATER SERVICES, COMMISSION GAVE THE OK TO PURCHASE WHAT WOULD BE NEEDED.
